What is the overall deductible ?	\$0/person or \$0/family for In- Network Providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the policy, the overall family deductible must be met before the plan begins to pay.
Are there services covered before you meet your deductible ?	Yes. Dental, Preventive Care , Primary Care Visit, Specialist visit, Tier 1a, Tier 1b, Tier 2, Tier 3 and Tier 4 Prescription Drugs , and Vision for In- Network Providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . What is the out-of-pocket limit for this plan ?	\$4,500/person or \$9,000/family for In- Network Providers .	The out-of-pocket limit is the most you could pay in a year for covered services.
