What is the overall deductible?	In- <u>network</u> : Employee \$0 / Family \$0.	See the chart starting on page 2 for your costs for the services this <u>plan</u> covers. A Health Reimbursement Arrangement (ERA) is available that works with your medical <u>plan</u> , as described in your employer's Summary Plan Description.
Are there services covered before you meet your deductible?	No.	You will have to meet the <u>deductible</u> before the <u>plan</u> pays for any services.
Are there other deductibles for specific services?	Yes. For <u>prescription drug</u> expenses - In- <u>network</u> : Employee \$300 / Family \$600. Does not apply to in- <u>network</u> for preferred generic drugs. There are no other specific <u>deductibles</u> .	You must pay all of the costs for these services up to the specific <u>deductible</u> amount before this <u>plan</u> begins to pay for these services.
What is the out-of-pocket limit for this plan?	In- <u>network</u> : Employee \$7,150 / Family \$14,300.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Do you need a referral to see a specialist?	Yes. A written <u>referral</u> is required for most <u>specialist</u> visits.
