## Does this plan Provide Minimum Essential Coverage? Yes.

**How your out-of-network care is reimbursed:**

Your plan does not cover care you get outside of our network. Generally, we will not pay anything for that care. If you get a bill for anything more, contact us.

- All medical and hospital services not specifically covered in, or which are limited or excluded by your **plan** documents
- Donor egg retrieval
- Experimental and investigational procedures, except for coverage for **medically necessary** routine patient care costs for members participating in a cancer clinical trial with respect to the treatment of cancer or other life-threatening disease or condition
- Home births
- Immunizations for travel or work except where **medically necessary** or indicated
- Implantable drugs and certain injectable drugs including injectable infertility drugs
- Long-term rehabilitation therapy
- Non-**medically necessary** services or supplies
